PARKWAY E SLOPE: CURRENT STATUS

Summer/Autumn 2021: With the ultimate goal of Anne Arundel County taking over the Parkway E hillside property and management (since 80% of the water comes from county roads), Sylvan Shores has engaged with County representatives and now pro bono legal counsel to assist in the project. The temporary fix is (as of this newsletter) holding for the time being. Native plants have been planted to further stabilize the hillside.

FISCAL YEAR 2021-22 PROJECT EXECUTION

- **Parkway E** Management and resolution of the slope erosion issue;
- Forest Pier Replace gravel on boat ramp and parking area;
- **Clubhouse** Gravel replacement, HVAC heat pump replacement;
- South River Pursue the grant process to install a living shoreline on the South River to stop erosion loss;
- Central Park Paving the boat ramp area;
- **Piers** Install solar lighting
- Shorewalk Dr. Research replacement of the bollards.

CLUBHOUSE


The Clubhouse is in need of several planned and (now) urgent repairs. The HVAC outdoor heat pump unit failed in the heat of early autumn, and must be replaced. Sylvan Shores has contracted with a company to install a replacement heat pump and thermostat with a 5-year parts warranty to be installed soon. Additionally, plans are being formulated for the 2022-2023 budget to replace the roof shingles (nearly 20 years old) and the inside ceiling, lighting, and fans. This will make the Clubhouse an even better space for community members' use. The Clubhouse remains <u>open</u> for rentals!

ROADS AND DRAINAGE COMMITTEE

Sylvan Shores is need of a Chair for the Roads & Drainage Committee to support the community. The Chair and committee advise the Board on all roads and drainage matters, provides oversight to all roads (county and community), develops budgets and recommends expenditures, and serves as the liaison to Anne Arundel County for road Please operations. contact SylvanShoresBOD@gmail.com if you are interested in chairing for participating in this essential standing committee.


ENTRANCE PARK

Please keep Entrance Park beautiful! This is a community spot where kids play and is one of the first nature areas we see when entering Sylvan Shores. As a reminder: please do not park on the grass at the Entrance Park area. This will damage the grass and leave muddy spots that are hard to reclaim over the winter months.



CENTRAL PARK PAVING

Sylvan Shores has contracted with a company for re-paving of the Central Park area (see picture). This will include 2" of new asphalt over new tack, 4" edging bump for water runoff, and a 1-year warranty.



The Central Park boat ramp area will be **closed**, weather permitting, to ALL access (vehicles and foot traffic) after 6:00 p.m. Sunday, November 21st. The area will be accessible by foot again on Thursday, November 25th. The gate for vehicle/trailer access will be <u>closed until spring</u> to allow for proper setting, and a new lock will be placed on the gate. A notice will be sent out regarding new keys for the spring at a later date. If there are any delays because of weather, the community will be notified.

FINANCE and BUDGET

The Sylvan Shores Services Company (SSSC) operates under two budgets: SCBD (Special Community Benefit District) and a Non-SCBD (SSSC) budget. Our SCBD budget is funded by our tax assessments for established purposes, and the SSSC budget is funded by fees from amenity rentals/leases (such as the Clubhouse or slip fees) for those expenses not allowed to be paid from tax assessments (such as tax preparation and audits, as well as some legal expenses).

The Current FY2022 Tax Assessment for the SCBD is \$477.68 per tax ID, billed by Anne Arundel County. These funds are used per the approved budget for projects and expenses during this fiscal year.



The proposed FY2023 budget has been mailed to the Sylvan Shores community, with a **Full Membership Meeting** Vote to be tallied on **November 22nd**, **7:00 p.m.**, at the Clubhouse.

PIER and WATERFRONT ACCESS: RULES and COMMON COURTESY

- All Piers and Parks are **open dawn-dusk**, closed to access and use at all other times for safety.
- Sylvan Shores has encountered issues with members and non-members accessing these areas unsafely after dark, to include setting fires, loud noise, and dangerous activity near the water.
- If you observe trespassers or dangerous behavior at the parks or on the piers, please contact 9-1-1 for police or fire emergencies, or the non-emergency police line at 410-222-8610.


Scary times in Sylvan Shores for Halloween!
