- <u>Parkway Courtesy</u>: All parkways should be kept clear of personal belongings so they are open to all and PLEASE do not dump yard waste (leaves, tree limbs, etc.) from your yards onto community property. The cleanup becomes an expense to the entire community; and
- <u>Leaf Cleanup</u>: To any new neighbors: Anne Arundel County does NOT pick up leaves from the street. It is our responsibility to dispose of leaves from and around our yards. Please do not blow your leaves into the street or onto the parkways.

I will close by sending, in advance, best wishes for happy holidays to come and a great winter season in Sylvan Shores; and thank you for your support and allowing me the opportunity to serve this community.



CLUBHOUSE UPDATES

It's been a great year for clubhouse rentals and we hope to continue this trend. We are going to be planning more updates in the coming months. The process has begun to contract for a new roof and repair the stairs on both sides of the clubhouse. We are also looking into replacing the drop ceiling with a drywall ceiling along with new lights and fans. After all of this, the inside will need a new coat of paint and new curtains. None of this will happen immediately, but the process has begun. The Sylvan Shores Clubhouse is a huge asset to the community, so caring for this property is a priority.

BOAT RAMP KEYS

Do you currently have a boat ramp key or do you think you will want a key next season, then this information is for you! During COVID, we made the decision NOT to have new keys made for 2 seasons. In 2022, we replaced the locks at both the South River and Hardestys Cove boat ramp area. This will return to being a yearly process, each year new keys will be necessary. BUT, don't toss those old keys because: turning in this year's key, when you purchase a new key for the 2023-2024 season, will get you a \$5.00 credit towards the \$30.00 seasonal fee. 
FUTURE PROJECT PLANNING

The Sylvan Shores Board of Directors is forward looking to numerous new projects to maintain and improve our community. While many of these still require budget approval by the membership, the Board is current assessing the feasibility of:

- Playground at Forest Park;
- Finger Piers at the South River Boat Pier;
- New Community Signs at both South River and Forest entrances;
- New benches at Central Park;
- Kayak Rack expansion at Forest Park;
- Additional steps at the Swim Pier;
- Restoring the sheds at the Ballfield;
- Replacement of the Shorewalk Rd. bollards;
- New basketball court;
- Clubhouse: new ceiling, interior lighting, fixing the front steps, a new roof, and rain gutters.

BUDGET MAILING FOR APPROVAL

It is time again for the community to review and approve the budget for Fiscal Year 2024, which will run July 1, 2023 to June 30, 2024. Keep a watch in your mail for this important community vote: it is your community and your funding! Sylvan Shores cannot operate and improve without resources or the continued volunteer support of our community.



FINANCE AND BUDGET

SSSC operates under two budgets: SCBD (Special Community Benefit District) and a Non-SCBD (SSSC) budget. The SCBD budget is funded by tax assessments for established purposes, and the SSSC budget is funded by fees from amenity rentals/leases for those expenses not allowed to be paid from tax assessments (such as tax preparation and audits, some legal expenses). 

MAJOR REPLACEMENTS, REPAIRS, AND NEW PROJECTS COMPLETED IN FY2022 INCLUDED:

- New gravel at the Clubhouse, Forest Park parking area, and lane to Hardestys Cove boat launch;
- Paving at Central Park boat ramp area;
- Installation of water utility at Forest pier;
- Replacement of Clubhouse HVAC;
- Replacement of fence and repair of ground area at Clubhouse (portion paid by insurance);
- Parkway D erosion control swale and adjustment to inlet grate of bioretention area;
- Stone steps to the swim pier path; and
- Lots of tree work with more to come!
- →These are all successful only because of community funding, community volunteers, and your support!



REPOLLINATE SYLAN SHORES

Hummingbird, butterflies, bees, oh my! Sylvan Shores received about 48 established pollinator plants through a grant by RePollinate Anne Arundel along with the University of Maryland Extension Master Gardeners and Anne Arundel County Watershed Stewards Academy. Those volunteers assist in propagating and growing valuable and difficult-to-obtain native plants. The U.S. Fish and Wildlife Service/U.S. Geological Survey, Native Bee Inventory and Monitoring Lab, Native Plant Nursery provided access and expertise; along with plant materials, hoop houses, and irrigated pens to enable the growth of these straight species herbaceous

perennials. The plants were put in at the Central Park boat ramp area – extending the Unity Garden grant from 2020 – and at the parking area at the Forest Park Hardestys Cove area.

Thanks to several volunteers who came out to put them in the ground: Ray Moody, Rachel Kline, Clare Allard, Lily Walther, Bill Bartolotta, Robin Cobb, Kathleen and Stephen Carney, Liz Stark, and Cathy Izzi.

- Golden Alexanders
- Purple Giant Hyssop
- Common Sneezeweed
- Rose Mallow
- Spotted Beebalm
- Black-eyed Susan
- Meadowsweet
- Pearly Everlasting
- Rattlesnake Master
- Wild Blue Indigo





We can't wait to see them in bloom from May to October!



STEPS TO THE SWIM PIER

Finally! A beautiful solution to a thorny problem. Sylvan Shores owns a set of stairs accessed from Shore Walk which leads to the South River and provide access to our South River community pier. The shoreline at the base of the stairs was *severely* eroded, completely undermining the stairs, and eliminating access to the beach and pier (other than by creeping along a community member's property...). After a series of false starts, we finally arrived at this solution involving riprap and a set of stone stairs leading from the wooden stairs directly to the beach. Thanks to Maguire Marine Construction and our waterfront committee for working together to solve this issue. While not perfect, it's certainly a dramatic improvement over the prior situation. We request that you please access the beach via the new stone stairs, and NOT across the neighbor's hillside.



SWIM AND PADDLE SOUTH RIVER:

Outdoor recreation on the South River was in full swing this Spring and Summer from Sylvan Shores! Neighborhood resident, Traci McNeil and her team hosted training swims for triathletes and both competitive and non-competitive swimmers of all ages. This 5th Annual Swim & Paddle the South River event in October helped to raise money and awareness for the Arundel Rivers Federation and the restoration and protection efforts they execute. Executive Director, Matthew Johnston helped to cheer the participants on!
