With this, we were required to close the use of the clubhouse, discontinuing rentals and in-person meetings. The Board is diligently working on creating a virtual "Zoom" system for members to attend board meetings, with details to follow when tested and confirmed.

Last season we did not re-key the boat ramp locks and we have decided that we will NOT re-key them this coming season either. However, if you need a key, please contact the Board and the standard fee will remain \$25.

# **CORRECTION – FY2022 SCBD Assessment**

There will be a slight <u>decrease</u> of the SCBD tax assessment this year since the County reviewed and changed the number of tax accounts to be assessed (adding one). This does not change the budgets presented and approved by the community: since the vote is on the budget and not the assessment. The SCBD budget has been sent to the County for their approval with the annual assessment of \$478.00 (down from \$479.49) based on 265 lots (up from 264).

### **BOAT SLIPS AND TRAILER STORAGE**

A new boating season is coming! Information regarding slip rentals and trailer storage will be sent out soon to current renters regarding renewals. If you are interested in either renting a slip or storing your *empty* boat/jet ski trailer please email to SylvanShoresBOD@gmail.com and someone will get in touch with you.

For past slip holders, you will get "first dibs" on the slip that you rented last year, but if you do not renew your rental by the end of April, and there is a waiting list, slips will be rented. The rental season runs from April 1st through March 31st.

During boating season: just because a slip is empty, that does not mean it is not rented. If you have a daily slip rental need, please contact the Board. There is a \$25 daily rental fee and a form that needs to be completed.

And lastly, the floating dock at Central Park is not a parking space. It is there for loading and off-loading only, no daily or overnight parking is allowed. Thank you for your cooperation and happy boating!

### NEW KAYAK RACK AT CENTRAL PARK: COMING SOON!

The current positioning of the kayak rack at Central Park is getting closer to the water with each day of shoreline erosion (which is another story, but it is being addressed...). The Board has mustered up a few volunteers and a design with budgeting has been approved so construction will begin very soon. If you currently have a vessel on the existing rack, be on the lookout for an email from Marge Farnan regarding the scheduling of moving from one rack to the other. Thanks everyone for your cooperation!

# 9 Remember When...

We thought it would be fun to create a column for each newsletter that someone that has family history, fun stories, multi-generational family still living in Sylvan Shores to share with the community. Before each newsletter, a community email will go out asking for participants to submit articles. It doesn't have to be old news, it could be new news, just fun, light and interesting. Our first submission is from our very own Board Member, Judy Moody. We hope you enjoy...

I was born and raised in the Sylvan Shores Community, growing up in a mostly summer cottage community that had some "summer only and/or weekends only" residents. The part-time residents on my end of the neighborhood were from the DC area. Some of the men worked on the first Bay Bridge with my Dad; some, I discovered later in my life, were actually related from many generations back.

Where the Riva Food Market is now on Riva Road was called Aunt Mary's store (she wasn't my aunt just the name of the store). It was funny because Aunt Mary had a store in Eastport when my Mom was growing up, so I couldn't do anything bad because she might tell my Mom! Down by the Riva Bridge beside the two restaurants, Paul's and Mike's, was the post office, George's Barber Shop, and the General Store. When we as teenagers we would go visit the Barber Shop when it was really hot outside because it had air conditioning and our house did not. My parents used to send us to the store to buy milk, bread, or cigarettes.

We had dirt roads back then. We swam all summer and ice skated either on Aisquith Pond or "the cove" (now referred to as Granville Creek) when the river froze. When we had a real good freeze, we would skate almost all they up river to Route 50. We play basketball and the clubhouse, we had teen club on Friday nights. Our play areas were Riva Farms (which we called Indian Hill) and the corn field that took us to Aisquith Pond for skating. The Caretaker's Cottage backed up to the ballfield (the caretaker was George Brown, "the tractor man"). Mr. Buddy's house also backed up to the ballfield and he took care of the ballfield as if it were his own. At Halloween, Mr. Elliott, who lived on Cove Road, would give us the BIG boxes of Cracker Jacks, and Mrs. Jackson made candy apples.

When it snows, the snow plow did not come to Sylvan Shores quickly, so sledding was the best! At Parkway D, between Dogwood and Elm, there was great sledding and Dogwood Road was really good when it was icy. Mrs. Wilson, who lived at the bottom of the hill didn't like us going over the jump to her property, but we did it anyway! <sup>(2)</sup> You could get a really long run on a sled by starting on Hillcrest Road, turning down Woodside and onto Poplar Road.

When I was young, Mr. Herd, who lived at the corner of Cove and Park Roads, had a sheep named Sugar. John Peake and I would ride Sugar around the block.

It was great fun growing up here because the county offered swimming lessons down at the swim pier and summer camp at the clubhouse. There was square dancing (called the County Squares) at the clubhouse, the fire hall had bingo on Friday nights and Las Vegas night in July.




